

ARUBA CLEAN AIR CAMPAIGN

This lobbying/legislative campaign of Rainbow Warriors International seeks to introduce local environmental legislation and to ratify and implement international treaties to ensure reduction of emissions of greenhouse gasses and regulate emissions of noxious and toxics, such as gases, aerosols, solids and other contaminants into the air.

Air pollution is a major environment-related health threat to children and a risk factor for both acute and chronic respiratory disease. While second-hand tobacco smoke and certain outdoor pollutants are known risk factors for acute respiratory infections.

Outdoor air pollution is largely and increasingly a consequence of the combustion of fossil fuels for transport, power generation and other human activities. Combustion processes produce a complex mixture of pollutants that comprises both primary emissions, such as diesel soot particles and lead, and the products of atmospheric transformation, such as ozone and sulfate particles formed from the burning of sulfur-containing fuel.

Outdoor air pollution remains a serious problem in cities throughout the world, particularly in the mega-cities of developing countries and it is estimated that a quarter of the world population is exposed to unhealthy concentrations of air pollutants. Children are particularly at risk due to the immaturity of their respiratory organ systems.

Unhealthy levels of air pollution harm the health of residents in many cities around the world, especially those who suffer from asthma. Medical studies increasingly show that air pollution plays a major role in triggering asthma attacks. Exposure to air pollution has been linked to increased use of asthma medications and an increased rate of emergency room visits and hospitalizations for asthma sufferers.

According to Environmental Defense in the USA, which organization runs the Clean Air for Life campaign, air pollution burdens our life, health and quality of life.

Its campaign emphasizes the dangers of smog and soot, both caused by dirty smokestacks in industrial plants, car tailpipes and stresses the need for cleaner industrial smokestacks and tail pipes of motor vehicles that run on diesel fuel.

The reduction of exposure to traffic pollution is also necessary as this will also decrease respiratory problems.
